MSHA Mine Safety Training Registration

1. **PRE-REGISTRATION IS REQUIRED FOR ALL CLASSES.**
2. Every Mine Operator & Contractor must have at least one person per shift or per crew who is Medic First Aid and CPR Certified!
3. A Part 46 or Part 48 Training Plan is required prior to attendance of any Mine Safety Class.
4. Your Annual Refresher is due each year before the end of the month you received your initial certification.
5. If your company changes from a Part 46 to a Part 48 training plan, you will be required to complete the initial training program, in order to maintain MSHA compliance guidelines.
6. Class prices are per participant and pre-registration is required.

You must have a **Part 47 Haz Com Program** as part of your MSHA Training Plan. You may be required to have your employees enrolled in a **Hearing Conservation Program** under Part 62 requirements.

Directions from Atlanta:

- Take I-75 north to I-575
- After exit 27, I-575 becomes I-515
- Continue on I-515 and turn right at the fourth traffic light onto Hwy-53.
- Travel approximately 2 miles and turn left at the fourth traffic light onto Burnt Mountain Road.
- Cross the railroad, tracks and the College will be on the left.
- For Economic Development Programs which include: MSHA Training, Continuing Education, and Business Services please take the first driveway and come through the large marble entrance of Chattahoochee Technical College Appalachian Campus.



Directions from Blue Ridge:

- Take I-515 South to Hwy 53 and turn left. (There will be a BP gas station and large shopping center with Home Depot and Kroger on your right).
- Travel approximately 2 miles and turn left at the fourth traffic light onto Burnt Mountain Road.
- Cross the railroad, tracks and the College will be on the left.

1. Head north on Capitol Ave SE toward Martin Luther King Jr Dr SE	79 ft
2. Take the 1st right onto Martin Luther King Jr Dr SE	0.2 mi
3. Turn left onto the Interstate 75 (North)/Interstate 85 (North) ramp	0.2 mi
4. Merge onto I-75 N	30.9 mi
5. Take exit 278 for Glade Rd toward Acworth	0.4 mi
6. Turn right at Glade Rd SE	390 ft
7. Take the 1st right onto Etowah Dr SE	374 ft
8. Take the 1st right toward Ross Rd	0.2 mi
9. Turn left at Ross Rd Destination will be on the right	0.1 mi
