# GADOE and TCSG DUAL ENROLLMENT'S MOVE ON WHEN READY (MOWR) PROGRAM

**ADMISSIONS POLICY** 

#### **MOWR General Admissions Policy**

Chattahoochee Technical College will serve qualified applicants who are able to benefit from a course or program of study. Specific programs of study have admissions requirements determined by the Technical College System of Georgia (TCSG) and by the college. These requirements are based on criteria developed to help students determine their potential for success in that program. Placement evaluations, satisfactory academic background and performance, and other appropriate measurements are used to determine readiness for program entrance.

<u>House Bill 149 (Move on When Ready)</u> provides an arrangement whereby an eligible student entering eleventh or twelfth grade who spent the prior school year in attendance at a public high school in Georgia may take all of his or her courses at or through an eligible institution and receive secondary credit from his or her high school with the goal of completing graduation and high school diploma requirements. Move on When Ready (MOWR) students are enrolled in both the high school and the postsecondary institution and earn credits at both institutions. The Move on When Ready Program, as established by the Georgia legislative Move on When Ready Act (O.C.G.A. Sec. 20-2-161.3,) provides opportunities for high school juniors and seniors to enroll full-time in postsecondary institutions to earn both high school and college credits. Students must maintain full time (12 credit hours or more) enrollment at the college to be enrolled in MOWR program.

Students seeking to enroll under MOWR **must** meet the dual enrollment admission requirements as set by the college. Once admitted, the participating student will take all coursework at or through the college.

#### **Admission Requirements**

HB 149 Move on When Ready Eligibility. To be eligible for participation in Move on When Ready, a student must:

- a. Be a high school junior or senior seeking a high school diploma from an eligible Georgia high school
- b. Be reported as enrolled in a Georgia public school for funding purposes during the preceding October and March fulltime equivalent (FTE) program counts
- c. Be enrolled **full time** in an eligible college or university or public technical college as a dual credit student taking approved college-level courses (*minimum 12 credit hours*)
- d. Be a legal resident of Georgia
- e. Maintain satisfactory academic progress towards fulfilling applicable high school graduation requirements

#### **College Entrance Assessment Requirements**

All applicants must take the COMPASS test for advisement and program placement. In lieu of COMPASS scores, applicants may submit official SAT or ACT scores, provided these scores are no more than 60 months old. If an applicant's alternative scores do not meet the College's Minimum Program Scores for program entrance, the applicant must be accessed via COMPASS. Testing information located on college website under prospective student/high school student.

#### **Other Admission Requirements**

#### **Admission Documentation and Procedures**

- Submit CTC College application form for admission.
- Submit a MOWR Participation Permission Form signed by the high school guidance counselor.
- Submit a copy of the SAT or ACT score results taken within the last 60 months. If these scores are not available, applicants will be required to take the COMPASS placement test testing information located on college website under prospective student/high school student.
- Applicants for some programs are required to submit additional documentation. See program's specific information for additional requirements.
- High School Counselors are advised to consult with CTC to identify the appropriate college course numbers.

- 1. Student must be entering the 11<sup>th</sup> or 12<sup>th</sup> grade and attended a Georgia public high school the previous school year. A full-time Georgia high school student during the prior year and counted in the October and March FTE counts.
- 2. Student must have been a legal resident of Georgia for at least 12 months.
- 3. Participation is limited to two years.
- Students seeking to enroll in the MOWR program will be expected to complete all coursework, GHSGT, EOCT and any other high school testing requirements as defined by the GADOE.
- 5. College coursework will be done at or through Chattahoochee Technical College. Courses can be taken beyond the regular school hours and/or through virtual courses.
- Upon completion of the courses, the student shall be responsible for requesting an official college transcript be sent to the student's local school system.
- 7. Courses taken must meet all graduation and high school diploma requirements.
- Student must be enrolled full-time (minimum 12 Credit Hours) and maintain full-time status at Chattahoochee Technical College. Student **must** notify the high school of their acceptance into college, his/her enrollment status, and of any schedule changes at any time at the Chattahoochee Technical College. If student falls below full-time status, student must withdraw from college and return to home high school.
- Tuition and fees are the only expenses covered by MOWR funding. The student and/or parents/guardians are responsible for all other expenses which include books, meals, lodging and transportation (Average cost for books ~\$500 per semester)

- 10. An eligible student enrolled at Chattahoochee Technical College for secondary credit shall not be eligible for any other state student financial aid at an eligible institution for courses taken under the program.
- 11. MOWR hours **do not count** against any hourly caps for HOPE scholarships or grants.
- 12. USG institutions do not allow students to transfer to another USG institution during an academic term.
- 13. Student's high school graduation could be affected by course incompletion, and/or failure. The college grade will be sent back to the high school for high school credit.
- 14. Students are allowed to participate in high school competitive and other extracurricular events. They must meet all requirements established by the Georgia High School Association and Rule 160-5-1-.18 Competitive Interscholastic Activities Grades 6-12. Conflicts with class requirements and scheduling could prevent the student from being able to participate.
- 15. Remedial and developmental courses are not available for MOWR.
- 16. MOWR is not available during the summer.
- 17. CTC does not guarantee the transfer of credit; it is up to the college for which you are applying to award transfer credit. Transferability of courses is up to the receiving college.
- 18. Student must follow all CTC policies, procedures, rules and regulations in the college catalog (i.e. No show policy, drop and withdraw policy, grade appeal, deadlines, etc.).

I request permission to participate in the SOAR Into College Early Program at CTC. I have received the counseling services concerning participation in a High School Program getting college credit. The school counselor has explained and discussed the program's guidelines and the student/parent responsibilities with me. My parents/guardians and I clearly understand what is expected of me to be able to enroll and to continue my participation in this program.

I understand that Chattahoochee Technical College is responsible for honoring college credit only. It is up to the receiving high school and high school guidance counselor to verify and confirm high school credits/courses are in compliance with high school graduation requirements. It is my responsibility to obtain my college transcript and submit it to my guidance counselor for high school credit.

I also understand participating students must be at least 16 years of age and currently on track to graduate from high school *(for example, is on track in earning English and Math credits towards high school diploma requirements)*; and, also must meet all the college's eligibility requirements for participation *(for example, must pass the college's entrance placement exam or have eligible ACT/SAT scores).* 

I understand I must be enrolled full-time (minimum 12 Credit Hours) and maintain full-time status at Chattahoochee Technical College. I understand I <u>must</u> notify the high school of their acceptance into the college, his/her enrollment status, and of any schedule changes at any time at Chattahoochee Technical College. If I fall below full-time status, I understand I must withdraw from college and return to my home high school.

I understand it is my responsibility to obtain a college schedule and to notify my high school of my college acceptance. I must also notify the high school if my enrollment status at the college changes. It is the responsibility of the high school student to obtain an official college transcript and turn it in to the receiving high school guidance counselor for high school credit.

It is my responsibility to meet my high school schedule of all required exit tests for my high school graduation. I understand if I fail my college course, the F will be on my high school and college transcript plus this grade may affect my High School graduation status.
