# **CLT Program Admission**

Students seeking admission to the Clinical Laboratory Technology (CLT) Program must be fully admitted to the college for Spring Semester 2014. To take pre-admission courses, students should enroll in the college's *Healthcare Science Certificate*.

The admission criteria consist of Admission Points with a total value of **470 points**. See the CLT Admission Points Criteria sheet for additional information.

# **Transfer Students / Transfer Credit**

If you are a transfer student, you must be fully admitted to Chattahoochee Technical College by spring semester 2014. The College's document deadline is December 13, 2013.

If you are transferring college credit into Chattahoochee Technical College, official transcripts must be received by the college's document deadline, December 13, 2013.

# **HOBET V (5.0) ATI Assessment Test**

Students must take the Health Occupations Basic Entrance Test (HOBET) Version 5.0 by <u>Monday, May 12, 2014</u> <u>and achieve</u> a minimum total adjusted score of <u>60.00</u>.

Students must also achieve the minimum test scores listed below in each area in order to be considered for admission into the program.

• Minimum scores:

Math – 60% Science – 60%

A student may take the HOBET <u>two (2) times in a calendar year</u> and <u>must wait a minimum of 30 calendar</u> <u>days</u> in between attempts. <u>A HOBET score is valid for five years and the Clinical Laboratory Technology</u> Program will use the highest scores of the last two attempts.

The HOBET is a standardized test that measures the student's ability in math, reading, grammar and science. A study guide and practice test can be purchased at <a href="www.atialliedhealth.com">www.atialliedhealth.com</a>. The HOBET is available through the Chattahoochee Technical College's Continuing Education Department. If the HOBET is taken at another college or testing center, the report must be sent from ATI to Chattahoochee Technical College.

#### **Application Session**

Applicants must attend an Application Session during Spring Semester 2014. Applications are only distributed during application sessions. The schedule for the application sessions will be posted on the CLT webpage on the college's website at the beginning of Spring Semester.

## **Orientation**

If admitted into the CLT program, all students must attend a **MANDATORY** orientation during Summer Semester, 2014.
