Ashley McIntosh is a passionate volunteer at VOICE Today, Inc., a non-profit organization that is ending the cycle and silence of child sexual abuse through awareness, prevention, and healing programs. Ashley graduated from Michigan State University in 2008, earning her Bachelors of Arts degree in Psychology, with a specialization in Women's Studies and Social Justice. She started volunteering with

VOICE Today in September 2013. During Ashley's time with Voice Today she has worked on numerous projects, such as researching and organizing the *Unveiling Child Sexual Abuse: A Mental Healthcare Professional's Role* presentation, reaching out to the Metro Atlanta school systems and Parent Teacher Association's about educational workshops on child sexual abuse, and assisting with the facilitation of monthly awareness workshops. She is currently working on her Masters of Science in Professional Counseling at Grand Canyon University and will graduate in January 2015. Ashley dedicates her free time to helping VOICE Today by spreading their message of "breaking the silence and cycle of child sexual abuse" and is passionate about women and children's issues.



Detective John McCraw began his law enforcement career in 1978. He retired from the Cobb County Police Department in 2012, after 28 years of services. He is currently a detective with the Acworth Police Department and handles their child

abuse investigations. He has been assigned to several specialized units within the Cobb County Police Department including the Narcotics and Homicide Units. Detective McCraw was assigned to the Crimes Against Children Unit and has been placed on the FBI Match Task Force to investigate Child Sexual Trafficking in the Metro Atlanta Area and is currently on the Georgia ICAC Task Force. John has completed CornerHouse Forensic Interview training, Finding Words & Advanced Finding Words of Georgia, Authorized Facilitator of Darkness to Light's Stewards of Children training, and Facilitator-Enough is Enough; an online training program for internet safety. He is currently the president of the Fraternal Order of Police 13 and has served as the second Vice-President of the State Fraternal Order of Police as well as Chair of SafePath's Prevention Arm. John was previously awarded Officer of the Year on two occasions while serving in the uniform division at Cobb County Precinct #3, been a recipient of the Drew Brown Community Service Award, and a recipient of the SafePath Prevention Arm VIP Award.



Tiffany Sawyer is the Director of Prevention Services at the Georgia Center for Child Advocacy, a child advocacy center whose mission is to facilitate the healing of children and families who have experienced child sexual abuse. She joined the staff of the Georgia Center for Child Advocacy in 2006. In her capacity at the Georgia Center for Child Advocacy, Mrs. Sawyer is responsible

for the statewide planning, coordination, implementation, and evaluation of the Center's statewide sexual abuse prevention initiative with the goal of training adults to prevent, recognize, and react responsibly to child sexual abuse.

Prior to her work in Georgia she worked for three years as the Associate Director of Programs at Darkness to Light, a national nonprofit for the prevention of child sexual abuse by putting the responsibility for prevention squarely on adult shoulders. While at Darkness to Light, she assisted in the creation of the Stewards of Children training curriculum and helped to launch the program on national and international levels. She serves on the Governor's Office for Children and Families' Commercial Sexual Exploitation of Children Taskforce.

Mrs. Sawyer earned her bachelor degree in French Education from the College of Charleston and taught high school French before getting involved in child advocacy. Tiffany has conducted over 400 trainings and presentations both nationally and internationally throughout her career. Some conferences include Governor's Second International Conference on Children, Hermosillo, Sonora, Mexico, Children's Act Grantee's Conference, Washington, D.C., Genesee County CASA for Children Conference, Child Sexual Abuse: New Perspectives on an Old Problem, Batavia, NY, and Georgia Grantmakers Alliance, Atlanta, GA. Patti Sipos holds a Bachelor's degree in Social Services. She has been employed for over 23 years at Cobb Department of Child and Family Services Child Protection Services. Patti has over 6 years investigating child abuse referrals and has worked on multiple high profile cases. The past 17 years she has supervised the Emergency Child Protective Services After Hours Unit. This unit works extensively with community partners ie: Law Enforcement (in all Cobb jurisdictions) and medical personal at all area hospitals. This collaboration incorporates the multidisciplinary concept, thus reducing multiple questioning of victims and aids in evidence gathering. The After Hours Unit services the emergency needs for foster care, family preservation and child protection and is on-call when the main agency is closed.



Chandra Southern was born in Brooklyn, NY and raised in Raleigh, NC. She is a proud Alumnus of William G. Enloe High School and Winston-Salem State University where she obtained a Bachelor of Arts degree in Business Administration with a Concentration in Marketing. Chandra is a
