### **Occupational Therapy Assistant Program Admission**

Students seeking admission to the Occupational Therapy Assistant (OTA) Program must be fully admitted to the college for the Spring 2018 semester. To take pre-admission courses, students should enroll in the college's Healthcare Science Certificate.

OTA program admission criteria consist of admission points with a total value of **390 points**. See the OTA Admission Points Criteria sheet for additional information.

### **Transfer Students / Transfer Credit**

If you are a transfer student, you must be fully admitted to Chattahoochee Technical College by Spring 2018 semester. **The College's document deadline for Spring Semester 2018 is Friday, December 8, 2017.**

If you are transferring college credit into Chattahoochee Technical College, official transcripts must be received by the College's document deadline, **Friday, December 8, 2017.**

### **Program Information**

The program requires five (5) semesters to complete (last 2 semesters are 8 weeks each of full-time Level II Fieldwork). Students are required to be full-time students for the duration of the program. For more information about occupational therapy: <http://www.aota.org>.

1. **ATI TEAS**

Take the **ATI TEAS Friday, December 15, 2017** and achieve a minimum Adjusted Individual Total score of **64 or higher**.

A student may take the **ATI TEAS two (2) times in a calendar year** and **must wait a minimum of 30 calendar days** in between attempts. The ATI TEAS score is valid for five years.

The ATI TEAS is a standardized test that measures the student's ability in math, reading, grammar and science. A study guide and practice test can be purchased at [www.atitesting.com](http://www.atitesting.com) The ATI TEAS is available through the Chattahoochee Technical College's Continuing Education Department.

**NOTE: Chattahoochee Technical College is no longer accepting scores from previous versions of the TEAS, TEAS for Allied Health or HOBET. The College will only use scores from the new version – ATI TEAS.**

2. **Application Session**

All applicants must attend an application session during Fall Semester 2017. Applications are only distributed and accepted during the application session. The schedule will be posted on the OTA webpage on the College's website by Summer 2017.

3. **Optional-Observation Hours**

**All hours must be submitted on or before Monday, December 4, 2017 by 3:00p.m. in order to receive extra points.**

Document awareness of the job requirements of an Occupational Therapy Assistant through volunteer occupational therapy observation and/or as an occupational therapy aide for a **minimum of 20 hours** in one of the following types of settings:

- 1) Skilled Nursing Facility (SNF)
- 2) Inpatient Rehabilitation Facility
- 3) Acute Care Hospital
- 4) School System

\*Must be direct patient observation under the supervision of an Occupational Therapist or Occupational Therapy Assistant (cannot be clerical work in a facility).

**Each clinical observation site should be provided with a Documentation of Occupational Therapy Observation Form (found on the CTC OTA Program web page). Student should verify number of hours documented and second page of form should be completed by the supervising OT/OTA. The supervising OT/OTA should be provided with an envelope in which to place the form and the seal MUST then be signed by him/her in order to be valid (forms delivered in envelopes with unsigned seals will NOT be accepted). **Accreditation Information**

The Occupational Therapy Assistant Program is accredited by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 4720 Montgomery Lane, Suite 200, Bethesda, MD 20814-3449. ACOTE's telephone number c/o AOTA is (301) 652-AOTA and its Web address is [www.acoteonline.org](http://www.acoteonline.org). Graduates of the program will be eligible to sit for the national certification examination for the occupational therapy assistant administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam, the individual will be a Certified Occupational Therapy Assistant (COTA). In addition, most states require licensure in order to practice; however, state licenses are usually based on the results of the NBCOT Certification Examination. Note that a felony conviction may affect a graduate's ability to sit for the NBCOT certification examination or attain state licensure.
