CLT Program Admission:

Students seeking admission to the Clinical Laboratory Technology (CLT) Program must be fully admitted to the college for Spring Semester 2018. To take pre-admission courses, students should enroll in the college's *Healthcare Science Certificate or Interdisciplinary Studies-Health Track*.

The CLT program has a competitive admission process. The selection criteria consist of Admission Points with a total value of **340 points**. See the CLT Admission Points Criteria sheet for additional information.

Transfer Students / Transfer Credit:

If you are a transfer student, you must be fully admitted to Chattahoochee Technical College by Spring Semester 2018. The College's document deadline for Spring Semester 2018 is **Friday, December 8, 2017**.

If you are transferring college credit into Chattahoochee Technical College, official transcripts must be received by the college's document deadline, **Friday, December 8, 2017**.

ATI TEAS:

Take the ATI TEAS by **Friday, May 4, 2018** and achieve a minimum total adjusted score of **65.00**. A student may take the ATI TEAS two (2) times in a calendar year and must wait a minimum of 30 calendar days in between attempts. The ATI TEAS score is valid for five years.

The ATI TEAS is a standardized test that measures the student's ability in math, reading, grammar and science. A study guide and practice test can be purchased at www.atitesting.com. The ATI TEAS is available through the Chattahoochee Technical College's Corporate and Professional Education Department.

Application Session:

All students must attend an Application Session and complete a program application during Spring Semester 2018. Applications are only distributed during the application sessions. The schedule for the application sessions will be posted on the CLT webpage on the college's website at the beginning of Spring Semester 2018. Late arrivals will not be permitted to enter the session.

Final Class Selection:

Final class selection is based upon the total number of Admission Points. The students with the highest point value will be accepted into the program.

Orientation:

If accepted into the program, all students must attend an orientation in August 2018.
