Annual and Endowed Scholarships



One of the most significant challenges higher education institutions have faced recently is providing the highest quality education possible for the most affordable price. When met with increasing expenses and an economic downturn, students are often forced to decide between continuing to invest in their education and devoting those funds to their families' needs or the general cost of living.

Each year, Chattahoochee Tech Foundation has nearly *fifteen times* as many students apply for scholarships than funds available. To meet this incredible need, the Foundation seeks to add \$500,000 in endowed funds and \$100,000 in annual scholarships.

Donors can create scholarships at Chattahoochee Tech Foundation in two ways:

Annual Scholarships: Starting at \$1,000 per year for three years

Annual scholarships are funds donated each year to support students with financial need. Donors can determine specific qualifications and name the scholarship according to their philanthropic interests. In order to make the most significant impact for students in need, *annual scholarships begin at \$1,000. Donors make a commitment of three years or more for annual scholarships.* This allows the Foundation to build a relationship between donors and scholarship recipients to demonstrate the long-term benefit of their support.

Endowed Scholarships: A minimum investment of \$25,000

Endowed scholarships are funds donated to the Foundation and invested through a long-term pooled investment fund. These scholarships are awarded in perpetuity based on interest earned annually from the investment. *Of this income, Chattahoochee Tech Foundation awards 80% to scholarship recipients and reinvests 20% to ensure the fund continues to grow.* This growth will allow for additional funds to be distributed each year. Like annual scholarships, donors can determine specific criteria and name the scholarship according to their philanthropic interests.
