STEP One: To complete your FAFSA, go to <u>http://www.fafsa.ed.gov</u>. You will need your completed federal income tax returns (and your parents information if you are "dependent"). If you are not required to file taxes, you will still need to provide income information. Include school code: <u>005620.</u>

Dependent Students:

- Under age 24 by January 1st of aid year
- Single
- No dependent children
- Not an orphan/ward of the court/State
- Not a Veteran

STEP Two: In completing the FAFSA, you (and your parents, if required) will sign the application using a **FSA ID**. If you don't have a FSA ID, you can create one when logging in to **http://www.fafsa.ed.gov**. You will create a username and password. You will enter your email address, name, date of birth, Social Security number, contact information, and challenge questions and answers.

After your FAFSA is processed by the

Department of Education, you will be notified via e-mail. CTC (and any other school(s) listed) will automatically receive this information. You will then be notified if additional information is required. If no further information is needed for processing, you will receive an award letter detailing your financial aid eligibility. <u>Check</u> <u>your CTC Student Email account regularly</u> for important financial aid updates. You will also Copies of federal tax returns <u>cannot be</u> accepted for verification purposes. For faster processing, use the <u>LINK</u> to the IRS DATA RETRIEVAL TOOL to import your tax information.

receive your SAR (Student Aid Report) via mail or email.

Check your financial aid status in BannerWeb. Go to me@CTC and log onto BannerWeb using your ID and PIN. In BannerWeb, you can view Required Documents, Financial Aid Award Amounts, Tuition and Fee Balances and Authorized Financial Aid and also Satisfactory Academic Progress.

If you have registered for the upcoming semester, you must adhere to the posted fee payment deadlines (*see Bursar's Office webpage*) for the semester in which you are planning to attend. If payment is not made or your financial aid file is not complete by the deadline, your classes will be dropped for nonpayment.
