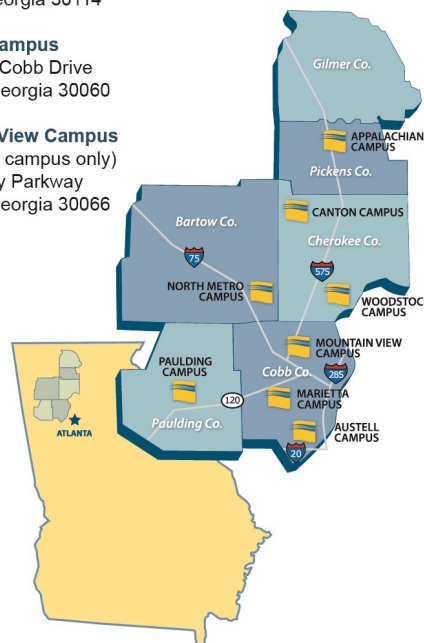

**Behavioral
Intervention
Team**



What is a Behavioral Intervention Team?

A behavioral intervention team (BIT) is a multidisciplinary group whose purpose is meeting regularly to support its target audience (students, employees, faculty, staff) via an established protocol. The team tracks “red flags” over time, detecting patterns, trends, and disturbances in individual or group behavior.

The team receives reports of disruptive, problematic, or concerning behavior or misconduct (from co-workers, community members, friends, colleagues, etc.), conducts an investigation, performs a threat assessment, and determines the best mechanisms for support, intervention, warning/notification, and response. The team then deploys its resources, and the resources of the community, and coordinates a follow-up.

BIT’s Role

- BIT’s primary function is to keep the College community safe.
- BIT is supportive in nature and seeks to act preventively with distressed persons.
- BIT is a multidisciplinary team of professionals from several College units including Campus Police, Human Resources, Student Affairs, Counseling, Special Populations and Title IX, Faculty, and External Affairs.

What Does the Team Do?

- BIT gathers and manages reported information from concerned students, faculty, and staff.
- Assesses the level of threat an individual’s behavior may pose.
- Makes referrals internal and external to the College.
- Provides faculty and staff with support and intervention resources.

What Should I Do If I Am Concerned?

- ♦ Speak with the individual and express your concern about their behavior and how it is impacting your environment.
- ♦ Inform and encourage the person to utilize support services that are available for them on campus.
- ♦ Offer to help them to make an appointment or walk with them to where they can get help.
- ♦ If you do not feel safe talking alone to the individual, seek support from a College representative from counseling, human resources, student affairs or campus police.
- ♦ When in doubt... Make a Call!!
- ♦ If you are uncertain whether an individual’s behavior is concerning, disruptive, or threatening, do not hesitate to consult with Campus Police or a College official.
