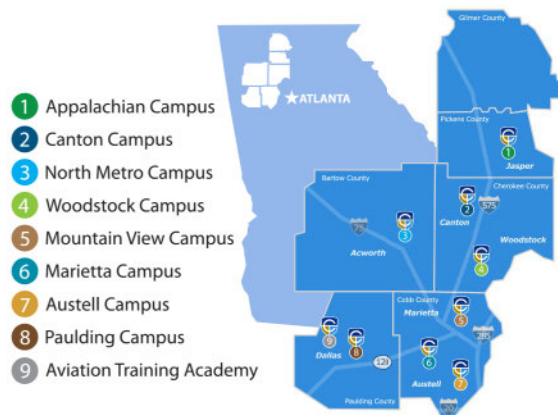

TITLE IX RIGHTS AND OPTIONS

Title IX of the Education Amendments of 1972 is a federal law that prohibits discrimination on the basis of sex in any federally funded education program. Employees, in their role under Title IX, are required to report all incidents of sexual violence and other sexual discrimination to the College. Additionally, "Responsible Employees" are required to advise students of their right to file a complaint with the College, regardless of their desire to pursue an investigation with law enforcement. CLERY/VAWA VICTIMS' RIGHTS AND OPTIONS

When a student or employee reports being the victim of dating violence, domestic violence, sexual assault, or stalking, whether on or off campus, the following options will be provided.

1. If dating violence, domestic violence, sexual assault, or stalking has occurred:

- **Get to a safe place**
- **Report the Incident**

- **Preserve Evidence**—Preserving evidence can assist in proving that the alleged criminal offense occurred or aid in obtaining a protection order. Preserve any evidence as soon as possible, even if you are unsure about reporting an incident or choose not to have a forensic exam.

Avoid drinking, bathing/showering, brushing your teeth, using mouthwash, combing your hair, changing clothes, if possible; this could destroy evidence. If you've changed clothes, place clothing and any bedding items into separate brown paper bags (plastic bags may ruin evidence).

Take photographs of visible physical injuries (bruising, scratches, etc.).

Write down everything you can remember, including a physical description of the assailant.

Sexual Assault Forensic Exam (SAFE or "rape kit")

If you choose to have a forensic exam, consider a medical facility where you can also receive comprehensive medical care. You can decide to complete a forensic exam confidentially. You have the right to refuse the entire exam or any part of it at any time. A SAFE ("rape kit") can only be completed within 5 days of the assault.

Drug-facilitated Sexual Assault— If you suspect you are the victim of a drug-facilitated (Rohypnol, GHB, etc. sexual assault, request that the medical facility take a urine sample.

Stalking— Because stalking involves multiple incidents, document details about each occurrence including date, time and location of each event; what happened; vehicle and license plate information; witnesses; was it reported; how the experience affected you and what changes you made in your life as a result.

Communications— Items such as mail, packages, and other physical articles, as well as evidence of electronic communications such as texts, emails, social media posts, chats, photographs, voice mails, videos, and websites can be helpful in a College or law enforcement investigation. Download communications, save to a .pdf, print out pages or take screen shots of phones and computers including the URL, time and date.

- **Law Enforcement Involvement** — Victims have the right to notify police or decline police involvement. If you choose to notify local police, campus police can assist with the notification. Law enforcement can collect and store evidence even if you do not wish to pursue an investigation, so that it's available should you change your mind at a later time.
- **Temporary Protection Orders (TPO) and No Contact Orders** - A temporary protective order is a legal document issued by the court to help victims obtain protection from persons abusing, harassing or stalking them. TPO's are issued through the Superior Court of the county in which the Perpetrator/Respondent resides. If the Respondent is not a resident of Georgia, the TPO may be issued in the county where the abuse occurred or where the Victim/Petitioner resides. You may also request a "No Contact Order" from Student Affairs: (770) 528-3554 if you feel threatened or unsafe.

2. Confidentiality

- **GA Law** — In accordance with Georgia Open Records Act, the College Police will not release the name or identification of victims of rape.
- **Mostly Confidential**— The College will protect the identity of victims to the fullest extent possible. When a victim wishes to remain anonymous or not have their

identity disclosed to a perpetrator, the college's ability to respond to the complaint may be limited.

3. Interim Measures Available

- The Title IX Coordinator or Student Affairs Representative can speak to you about possible changes to academic, living, transportation or working situations. These remedies may be made if they are reasonably available, regardless of whether or not you choose to report the incidents of sexual misconduct or interpersonal violence to campus police or local law enforcement.

4. Code of Conduct

- **Victims may choose to file conduct charges for violation of policy** - Student Affairs Staff members are available to guide you through the conduct process and answer any questions. Contact Student Affairs at the Marietta Campus:
