STEP 1: Prior to applying to the Medical Laboratory Technology program, all prospective students must first apply via the website to the college, be admitted and have a student ID number.

STEP 2: View Program Video Session – Mandatory

Applicants must view the program video in order to submit the program application. Video is located on our website by following these steps to reach the program page. Applications will be reviewed by end of the Spring Semester.

Competitive Medical Laboratory Technology Program Admission:

Students seeking admission to the Medical Laboratory Technology Program must be fully admitted to the college with transcripts fully evaluated (for transfer credits) by the end of Spring Semester.

The Medical Laboratory Technology program has a competitive admission process. The selection criteria consist of Admission Points with a total value of **270 points**. See the Medical Laboratory Technology Admission Points Criteria sheet for additional information.

All students must have a GPA of **2.0** or higher in their pre-requisite courses to be considered for program admission.

Option 1: Students who complete the CHEM coursework by **the end of the Spring Semester** with a grade of a “C” or higher will have the opportunity to earn extra points towards competitive admissions. See the Medical Laboratory Technology Admission Points Criteria sheet for more information.

Option 2: Completing the CHEM coursework **after Spring Semester** with a grade of a “C” or higher, will satisfy the course requirement but not earn additional points towards competitive admissions.

*Note: If you are selected for the program prior to having completed the CHEM coursework, it must be completed by the end of your **first Fall Semester** in the Medical Laboratory Technology program; otherwise you will be unable to move forward in the program. It is highly recommended to complete the CHEM coursework prior to starting the Medical Laboratory Technology Program.

Additional required courses:

Immunizations:

Chattahoochee Technical College does not require vaccinations as criteria for admission and enrollment of students; however, immunizations are required for college health programs by our clinical partners. Students may not complete clinical rotations without meeting clinical site immunization requirements. All required vaccinations must be complete prior to starting clinical practice. Students completing internships or practicums in other majors must adhere to all job site vaccination guidelines. Clinical and job site requirements can and do change without notice or input from the College.

Final Class Selection:

Final class selection is based upon the total number of Admission Points. The students with the highest point value will be accepted into the program. A mandatory program orientation date will be posted in the student's acceptance letter. All notification letters are emailed to Chatt Tech student email addresses. Once accepted, student program of study will be changed to Medical Laboratory Technology.
